Standard maximum insurance liability up to €500 per consignment.

Duties and taxes may be payable by the consignee on shipments with a value above US\$ 1,000.00

A pro-forma or commercial invoice must be supplied in the case of all non-documents consignments.

\* All non-documents shipments must be accompanied by an export declaration on form CN22 (shipments up to £270.00 value) or CN23 (shipments over £270.00 value) – these forms are available for download from our website or can be completed on your behalf for a service charge of £5.00 per declaration.
